2020 Results: 29,477 individuals visited the food shelves, Foodmobile distributions, drive thru events and home delivery program and we distributed nearly 1.8 million pounds of nutritious food to families in need. 280 households/532 individuals received emergency crisis assistance, 1,547 community volunteers contributed 15,784 hours of
